Ship Assist Tugs authorised for use within the Port of Southampton (Amended)

NOTICE IS HEREBY GIVEN that only the tugs listed within this notice are approved for use as ship assist towage within the Port of Southampton Statutory Harbour Area.

Amendments to authorised tugs will be provided by a change to this notice and will be re-issued appropriately.

Towage providers are required to submit a letter noting compliance to the ABP Towage Service Provider Requirements & Southampton Guide To Using Tugs for Ship Assist found on the Southampton VTS Website.

Tugs authorised for use within the Port of Southampton may navigate within the Precautionary Area when clear channel vessels are also in this area provided that the tug:

- 1. does not impede the clear channel vessel;
- 2. must request traffic clearance from Southampton VTS in agreement with Clear Channel vessel;
 - 3. this does not apply during periods of restricted visibility (1nm or less).
